### **Summary<sup>\*)</sup> of the Most Important Provisions of the Legal Protection Insurance Contract (for Criminal Procedures)**

**Concluded between Rotary International,  
Districts 1910, 1911, 1912, 1913 and 1920  
and HDI Insurance Corp.**

#### **Preliminary remark**

In connection with the certification of the Youth Service, the district governors have decided to take out a sufficiently high criminal-risk insurance policy, also valid in North America, to protect all acting persons from unjustified accusations and to protect these persons and our Rotary International community from possible financial disadvantages. In combination with the traceability of all processes and their long-term archiving provided by the founding of the "Rotary Youth Exchange" association, this provides suitable protection.

If, contrary to our many years of experience, the accusation of criminal conduct is justified, the controls established as part of the certification process will limit any criminal consequences to those persons who have been proven to be at fault.

Legal expenses insurance covers the costs of court, defence, experts, travel, etc., but not the penalty itself and any obligation to pay damages.

All activities of the insured organizations and persons in the context of their youth work in the framework of the principles of Rotary International, e.g. beneficial, social, humanitarian, educational and peace and friendship among peoples advocating activities with youth and for youth.

Family members, former and present employees and other staff members of the insured organizations; in the context of exchange programs arranged by the policy holder: exchange pupils, exchange students, scholars, host parents and host children and their family members and other responsible persons (e.g. teachers, instructors, other guardians) carrying out the duty of supervision with knowledge and in the interest of the policy holder or the coinsured organizations.
